ORDINANCE NO. 3 SERIES 2015

An ordinance relating to the adoption of an annual budget for the City of Beechwood Village for the Fiscal Year July 1, 2015 through June 30, 2016, estimating revenues and resources and appropriating funds for the operation of the City Government.

Whereas an Annual Budget Proposal and Message has been prepared and delivered to the City Council and Whereas, the City Council has reviewed such budget proposal and made necessary modification.
